





CONTEST GUIDELINES

A. OBJECTIVES

The Fellows' Research Paper Contest (FRPC) aims to serve as a platform that will uphold and nurture the value of research for fellowship trainees in the field of Philippine ophthalmology. It endeavors to contribute to a positive learning environment with integrity, diversity and value of collaboration in the advancement of the practice of ophthalmology.

B. ELIGIBILITY REQUIREMENTS

- 1. This contest is open to all fellows of ophthalmology fellowship training programs in the Philippines.
- 2. The participant must be the first author. The research must be done during the author's fellowship in ophthalmology. If there are co-authors, the participant must submit a document signifying their consent for the manuscript to be included in the competition.
- 3. The first author can be a fellow at the time of presentation or a recent graduate (not more than 12 months after completion of fellowship).
- 4. The principal author is the preferred presenting author, and should be a registered delegate of the 2024 PAO Congress.
- 5. The research paper should have received technical and ethical approval from an institutional review board or its equivalent.
- 6. The research paper should be original and may be either author-initiated or institute-initiated. The research paper may be in the form of a meta-analysis, chart review, pilot study etc., except case studies.
- 7. The following are prohibited:
 - a. Studies initiated and/or sponsored by pharmaceutical companies, ophthalmic manufacturers or ophthalmic distributors.
 - b. Studies that are part of an international study. Data from an international, multi-arm study cannot be mined and used for this competition.
 - c. Studies previously submitted for publication, whether or not accepted for publication.
- 8. Multiple research papers may be submitted by one author.
- 9. All manuscripts must be accompanied by an anti-plagiarism/similarity report from iThenticate 2.0 before submission.
 - a. Similarity and AI detection reports must be signed by at least one

adviser.

- b. Criteria for iThenticate 2.0 report acceptability is as follows:
 - i. The similarity report should yield a score of **less than 30%.**
 - ii. AI detection report should yield a score of **less than 20%.**
 - iii. Manuscripts with a score of more than 30% for similarity and more than 20% for AI detection will not be accepted.
- c. All institutions have been given access to the PAO iThenticate 2.0 subscription. Kindly ask your Fellows' Training Officer or Chair if access has not been given.

C. MANUSCRIPT REQUIREMENTS

1. Preparation of the manuscript shall be based on the "Uniform Requirements for Manuscripts Submitted to Biomedical Journals: Preparing a Manuscript for Submission to a Medical Journal" established by the International Committee of Medical Journal Editors

(https://www.icmje.org/recommendations/browse/manuscript-preparation/)

- 2. The manuscript must be typewritten, in **Times New Roman**, font size 12, double-spaced, in 8.5 X 13 inches legal paper with 1.5-inch margins on each side. Page numbers must be located at the right lower corner of each page (eg. page 1 of 10).
- 3. References are to be properly appended. You may refer to Uniform Requirements for Manuscripts Submitted to Biomedical Journals: Preparing a Manuscript for Submission to a Medical Journal" Section G.
- 4. Disclosures of funding sources or any conflicts of interest must be mentioned in the manuscript and at the start of the oral presentation. Please be guided in using the ICJME uniform disclosure form

5. Authorship and contributorship must be mentioned using guidelines from "Uniform Requirements for Manuscripts Submitted to Biomedical Journals: Ethical Considerations in the Conduct and Reporting of Research: Authorship and Contributorship"

- 6. Manuscripts must include the following sections
 - a. Title Page
 - b. Abstract
 - c. Introduction
 - d. Methods
 - e. Results
 - f. Discussion
 - g. Conclusion
 - h. References
 - i. Tables
 - j. Illustrations (Figures)
 - k. Units of Measurement
 - I. Abbreviations and Symbols
- 7. Participants must submit their manuscripts **WITHOUT** identifying information of authors and institutions.

The following documents are required and must be submitted via the website. Please adhere to the format of file titles shown below.

Note:

- If the research title is too long, include only the first 8 words in the file title.
- Files should be in PDF format.
- Incomplete entries and entries submitted via email will not be accepted.
- a. Consent from co-authors for inclusion of the manuscript in the contest

b. Manuscript without identifiers in the text

c. iThenticate 2.0 Similarity and AI detection reports

D. CONTEST PROPER

- 1. The manuscripts and iThenticate 2.0 reports will be sent to the panel of judges for preliminary screening.
- 2. The Board of Judges will be composed of one head judge and two members. The Head Judge will be an ophthalmologist with a background in research, academics or evidence-based medicine. The members will have a background in research or academics.
- 3. Participants are not allowed to reveal their names, the names of their coauthors, or their institutions during the presentation. Institutional logos in audiovisual aids or clothing are likewise not allowed.

F. CRITERIA FOR JUDGING

1. Manuscript (85%)

The Board of Judges shall grade the manuscript prior to the oral presentation. Oral presentations shall be judged during the annual convention. Points from the manuscript and the oral presentation will be tallied to determine the final scores.

G. DEDUCTIONS

- 1. A **5% deduction** will be given to FRPC manuscripts or slides bearing any identities of the authors or institutions (including logos and acronyms).
- When a presenter goes beyond the allotted time of eight minutes, a 5% deduction from the total score will be given for every minute over the allotted time.

H. AWARDING

The 1st, 2nd, and 3rd place winners will be based on the mean scores of the participants. The first placer will have his/her name & institution engraved on the PAO Research Cup. The PAO Research Cup will be kept by the winning institution for one year. The PAO Research Cup will be passed on to the winner of the succeeding year. The decision of the Board of Judges shall be final.
